Congratulations on having achieved Scouting's highest rank. As of today, you are an Eagle Scout. We hope you will always exemplify the Scout Oath and Law throughout your life. As an Eagle Scout, you are also committing to act as an ambassador of Scouting. We hope you will invest some of your time and talents in helping others achieve and excel.

We will be sending your completed application to BSA's National Headquarters in Irving Texas. They usually respond within 3 to 4 weeks time. Once you have been notified that your application has been approved, you may then schedule your Eagle Court of Honor. If you don't hear anything in 6 weeks, please contact a member of your Eagle Board of Review (listed on other side) so they can follow up.

The Eagle award can be picked up from the Chief Seattle Council. (Or they will mail it to you for a shipping fee if you contact them. Phone number: (800) 262-0133 or (206) 721-5945). You may choose to "upgrade" your award which includes mother's and father's pins for an additional amount of about \$11. To upgrade, notify the Council and they will instruct the Scout Shop.
