The Counselor-in-Training Staff will receive lodging, meals, and Accident Insurance during this period. You and your parents/guardian agree to pay the Mohegan Council \$45.00 per week (in advance) in which you serve as a Counselor-in-Training Staff member and understand you will receive no compensation for the periods in which you serve, including claims for Unemployment.

Other considerations agreed upon as part of this service agreement are listed below. Mohegan Council further reserves the right to terminate this agreement on verbal notification (followed by a written notice of termination) at any time, because of unsatisfactory performance or violation of Treasure Valley Scout Reservations policies. In the event of such termination, a refund will not be made for fees paid.

The purpose of the Counselor-in-Training program at Treasure Valley Scout Reservation is to introduce a young person to future service on a Treasure Valley Scout Reservation Staff.

Counselor-in-Training Staff will be introduced to a variety of programs, and administrative areas of the camp. During the course of the experience, the Counselor-in-Training Staff may be assigned to a specific area.

CONDITIONS OF AGREEMENT

1. The Counselor-in-Training Staff member must be a current registered member of the Boy Scouts of America
2. The Counselor-in-Training Staff member agrees to abide by all Boy Scouts of America, all local and Commonwealth Massachusetts policies that govern summer camp operation
3. The Counselor-in-Training Staff member agrees to abide by all policies outlined in the Staff Handbook and those for the Counselor-in-Training program.
4. The staff member agrees that the principles of the Scout Oath, and Promise and Law must be practiced as a way of life.

5. The Counselor-in-Training Staff member agrees to set an example of excellence in Scouting, which includes the proper wearing of the uniform.
6. The Counselor-in-Training Staff member agrees to participate in Counselor-in-Training Staff programs.
7. The Counselor-in-Training Staff member agrees to accept lodging as assigned by the Camp Director.
8. The Counselor-in-Training Staff member understands that the camp will provide all meals and housing.
9. The Counselor-in-Training Staff member agrees to perform other duties as required and/or assigned by the Camp Director or designee
10. The Counselor-in-Training Staff member understands that Mohegan Council is not responsible for the loss of his/her personal effects due to fire, theft, etc.
11. The Counselor-in-Training Staff member understands that he/she will not be reimbursed for any unapproved purchases made. Receipts must be presented for all reimbursements to the Camp Clerk or designee.
12. Counselor-in-Training Staff may be asked to return for additional weeks, but are not required to accept nor guaranteed such a request will occur. If the Counselor-in-Training Staff remain for an additional week, the fee must be paid.
